



Derek 'Van' Quackenbush

VALLEY CENTER, Calif. – Derek "Van" Quackenbush, 93, of Valley Center, Calif., passed away peacefully on Jan. 25, 2015, at Palomar Medical Center, Es-

condido, Calif., after a brief illness, with his wife Marge and daughter Ann by his side.

Van was the former owner and publisher of the Warsaw Bulletin, Hamilton Pilot, and Hancock County Journal Pilot newspapers.

Born in Minneapolis, Van attended Culver Military Academy in Indiana and received his bachelor's degree from Dartmouth College.

He served in Italy with the 15th Air Force during World War II, and went on to use the G.I. Bill to get a second degree in journalism from the University of Missouri.

In 1949, he became editor of The Warsaw Bulletin, Warsaw, Ill., and owner in 1950. One of his advertising accounts was the Peoples Store next door, where he met and married the owner, Marjorie Bott.

Deciding to go west, he sold the Warsaw Bulletin and moved to Del Mar, Calif., with his wife and two daughters. There, he founded the Del Mar Surfcomber. He went on to own the Poway News-Chieftain in Poway, Calif.

Van and his family moved back to Hamilton, Ill., in 1968, founding the Hamilton Pilot and acquiring the Hancock County Journal in Carthage, Ill., and combining them as the Hancock County Journal-Pilot in 1970, with Van as publisher and Marge in charge of advertising. He also owned the smaller Bowen Chronicle newspaper. One of his many local contributions was promoting construction of the new Hamilton-Keokuk bridge which replaced the former 100-year-old structure spanning the mile-wide Mississippi River. After putting the papers "to bed" each week, he enjoyed riding his bike home along the scenic River Road and sailing his 26-foot cabin cruiser with his family.

After selling the newspapers, Van and his family moved back to California, and in 1974, started The Valley Center Roadrunner, which he and Marge published until retiring in 1990. Through his newspaper career he has owned 10 newspapers in various states including Minnesota, Illinois and California.

Van was a'member of Rotary in Valley Center and served on the Chamber of Commerce board for 17 years. He enjoyed his family and friends, and for many years, playing the piano, golf and bridge, playing saxophone in a combo band and attending local community events.

He was preceded in death by his parents, Van and Hazel Quackenbush of Valley Center.

He is survived by his sister, Diane Quackenbush of Bloomington, Minn.; his wife, Marjorie; daughters, Susan (Jerry) Metternich of Hamilton and Ann (Kim) Kunde of Valley Center; grandchildren, Molly and Matthew Metternich of Hamilton and Brandon and Ryan Strausbaugh of Valley Center; and a greatgrandson, Brayden Bowman of Hamilton.

A memorial service will be at 2 p.m. Sunday, Feb. 22, at Valley Center Cemetery, with the Rev. Jay Littlefield of Sheridan, Wyo., officiating.

Hancock Co. Journal-Pilot founder

dies at 93

Some Hancock County Journal-Pilot readers might remember picking up their newspaper each week and looking for the top headline on the front page beneath the masthead of the Hancock County, Ill., Journal.

"Pilot" was added to the name in January 1974, and it has remained that way ever since.

Van Quackenbush. owner of the Hamilton. Ill., Pilot, purchased the Hancock County Journal as well as the smaller Bowen, Ill., Chronicle in 1970.

After a merger of the Hancock Journal and the Hamilton Pilot was completed in the fall of 1973, residents were introduced to the Hancock County Journal-Pilot.

Quackenbush, 93, died Jan. 25 in California.

following a brief illness. He received a bachelor's degree in Spanish from Dartmouth College before serving his country in Italy with the 15th Air Force division in World War II. His service led to a second degree and a new career.

Quackenbush used his G.I. Bill to attend the University of Missouri, earning a bachelor's degree in journalism. He used his expertise and position to champion causes in Minnesota, Illinois and California.

After beginning a paper in his home state of Minnesota, Quackenbush settled in Illinois for the first time in 1949 when he became editor of The Warsaw, Ill., Bulletin. He purchased the newspaper in 1950, and operated it for 11 years.

It was there that he met Marjorie Bott, who ran a business next door that advertised in the Bulletin. They were married a short time later, and Marjorie took over advertising sales and business operations while Quackenbush continued to use his editorial prowess in several places.

Quackenbush, his wife and their two daughters moved to California, where he

founded the Del Mar Surfcomber. After selling the Surfcomber, Quackenbush bought half interest in another California paper before taking a brief stint as a journalism instructor at Palomar College in San Marcos, Calif.

He and his family moved back to Illinois in 1968 and purchased the 79-year-old Hamilton Press. Quackenbush renamed it The Hamilton Pilot and moved it to 908 Broadway.

He was active in numerous clubs and organizations, including Kiwanis.

He also participated in civic development, from new sidewalks to the construction of the Hamilton-Keokuk bridge. Quackenbush served on the Hamilton Bridge Committee, helping secure funding and support for the new structure.

Quackenbush enjoyed boating on the Mississippi River. He and his family would spend their leisure time on his 26-foot boat and sail to Hannibal, Mo.

In March 1974. Quackenbush sold the Journal-Pilot and moved his family back to California, where he began several other newspaper businesses before retiring in Valley Center, Calif., in 1990.

For a man who enjoyed being in his boat on the river that borders Hancock County. fought in World War II with the Air Force and made newspapers his life's work all over the country, the word "Pilot" is a fitting legacy to have.



VETERAN DIES


James W. Qu cksell Passes Away at His Home In This City.

James W. Quicksell died yesterday morning at 2:40 o'clock at his residence, 724 Palean street. Death resulted from the effects of a wound received at the battle of Shiloh, Tenn.

on April 6, 1862.

The late Mr. Quicksell was born in Philadelphia, Penn., on February 17, 1842. He came to Keokuk several years prior to April, 1861, when he enlisted in Company A, Second regiment of Iowa infantry volunteers. During the war he fought with great bravery and distinction and received three wounds. In the fall of 1861, he was accidentally wounded in the arm by a bayonet thrust received while descending from an upper bunk at Benton barracks in St. Louis. In the famous charge of the Second Iowa at Fort Donelson on February 15, 1862, in which over a third of the regiment were killed and wounded, he was slightly wounded in the stomach. His third wound was received at Shiloh, a ball entering his right shoulder, passing under the shoulder blade and lodging near the back bone. He was taken prisoner at Shiloh and confined in a confede: ate hospital at Jackson, Miss., where surgeons probed repeatedly for the ball but failed to secure it. After he was paroled he re-entered the Union lines at Corinth and was discharged on account of his wound. In January, 1864, he re-entered as a vteran recruit in Company C. Third regiment of Iowa cavalry volunteers and served until the close of the war.

He is survived by his father, who is now living in Philadelphia, Penn., and his wife, a son, Alonzo, and a daughter, Bessie, who are now residing at the family home in Keokuk.

At the age of 29, he received a valor award for crawling out on the

ice on Muchattoes Lake in New York and saving the lives of two boys who had fallen through the ice.

He moved his family to this area in 1971. He was a member of Disabled American Veterans, VFW Post 1805, American Legion and the NRA. He retired from DuPont as a supervisor after 38 years of service.

He married June Mathews Yeoman on Feb. 14, 1946, in Newburgh. She survives.



He's proud and patriotic. He's sad, scared, mad and bitter. Staff Sgt. Wilbur "Lee" Quinn, 58, of Montrose is looking death in the face and he's not ready to go.

Since the 1960s, Quinn has been ready to go when his country called. He served in Vietnam as a young man. In 2003, at the beginning of Operation Iraqi Freedom, he went into Baghdad with his unit at age 54. He volunteered for the first Gulf War, Desert Storm, in 1991 but wasn't asked to go.

tion. He faces chemotherapy when he returns from D.C.

"When I was first diagnosed about a year ago, I was given one, or two to five years to live," he said. "After the last biopsy (of his lungs) I have three to five months."

Skin cancer has a high cure rate if it is treated early, but neglect can allow the cancer to spread, causing disability or death. Squamous cell cancer is malignant, involving cancerous changes to the cells of the middle portion of the epidermal skin layer. It is more aggressive than basal cell cancer. It is more likely than basal cell cancer to spread (metastasize) to other locations, including internal organs.

Quinn's diagnosis from 2003 to 2006 was that he had a fungus.

"I joined the army in January, 1967," said Quinn. "I was out of high school and can't really say what motivated me to join."

He attended basic training at Fort Bliss, Texas then trained at Fort Leonardwood. Mo., to work on heavy equipment.

After serving a year in Germany and receiving more training at Fort Knox, Ky., Quinn was ready for a change.

"I requested Vietnam," he said. "I was tired of serving in the states. There was too much emphasis on spit and polish. I See BENEFIT, Page 22

was a Specialist 4 and sent to Cam Ranh Bay in the early part of 1969 to serve with an artillery unit. We were known as 'Defenders of the DMZ.'

In October 1969, the artillery unit was deactivated. In those days, a unit was based overseas and soldiers rotated in and out individually. Since Quinn's year was nine months over, the Army sent him home because it would have taken too much paperwork to assign him to another unit.

Quinn was honorably discharged in 1973. He returned to Montrose and married Debbie, of Keokuk in 1975.

Quinn joined the 224th in Keokuk in 1982. After seven

years, he left the National Guard and in January 1989 joined C Company of the 389th reserves in Middletown.

"I'm still an 'active' member," he said. "I last drilled in November 2006 for my once-amonth drill. During our summer drills we went to Germany one year and El Salvador one year.

"In February 2003 our unit was notified we would deploy to Iraq. We had a two-week training camp at Middletown. The first of March we were put under federal orders and sent to Fort Leonardwood. We were packed into a gym, like sardines, about 1,000 of us. We had further training."

It was while in Fort Leonardwood that Quinn first went to the doctor with a severe skin irritation.

"I showed him my problem," he said. "He didn't even get up from his desk, just looked at me and said it's a fungus. I was given antibiotics and told to use athletes' foot powder. Right then I think that doctor signed my death warrant."

Quinn's unit first arrived in Saudi Arabia. In May 2003, it convoyed trucks into Iraq.

"We convoyed up to Baghdad, right through the middle of Iraq," he said. "Our advance party went out and bulldozed some dirt, spread gravel and we laid out the camouflage and slept in platoon size tents for a month and a half. I've seen summer temperatures hit 160 degrees. We got air conditioning in November. I was happy about that."

Quinn's skin irritation was getting worse and he saw the battalion doctor in Iraq a few times.

"He actually looked at it but said the same thing, it's a fungus," said Quinn. "There was no way they were going to ship me out of there to get tested."

In May 2004, the 389th came

back through Fort Leonardwood for outprocessing.

"They were supposed to run us through an extreme physical," he said. "All that happened is we signed papers."

Quinn saw a doctor once more at Fort Leonardwood but according to Quinn, the diagnosis didn't change.

"I figured it was a fungus," he said. "I went to a family practitioner in March 2006 who said it's cancer. It needs to be taken care of right away. I balled when I heard 'cancer.'

"I was sent to a specialist and we're back to the fungus diagnosis. I was prescribed ointment. It got worse immediately. The specialist called me back in a few months for a follow-up. Finally, he said cancer and began setting up appointments for me at the hospital. But I told him I have no insurance, and I'll need to go to the VA."

Quinn had his first surgery, including a circumcision, Aug.

29, 2006. He attended monthly drills through November and underwent two more surgeries Dec. 13; a fourth on Jan. 24; a fifth on Feb. 28 and a sixth on March 5.

"Now they want to do another surgery, but I want to go to the Vietnam Wall," he said. "They've removed the lymph nodes on my left side and scoped my stomach. The last time, they had to biopsy my lung and it hurts to breathe.

"I've always wanted to see the Vietnam Wall. After my unit in Vietnam was deactivated, the rest of the guys who had to stay longer were transferred to a transportation outfit. I heard they lost 25 to 30 percent shortly after that. Six months later, they about got wiped out. I'll probably recognize some names."

He has been able to come home between surgeries at the Veteran's Hospital and has the use of a friend's motorized chair.

"The VA has treated me very well, "he said. "I haven't heard a thing from my company commander or anyone.

"When I came home from Vietnam, I had human urine and feces thrown at me as I walked down Main Street in Keokuk," he said. "I was called 'baby killer.' But being ignored by the Army now is a worse slap in the face. I would go again if could. Now, I feel swept under the carpet. The Army will use you when they need you but drag their feet from doomsday to Hell when you need them."

Second Lt. Norma Cabanas, C Co., 389th unit administrator, said this morning she is catching up with unit business after being absent for six months.

"Quinn is a priority," she said. "I have a meeting with him today. I'm going to his home to help get paperwork taken care of and see what he needs."
